

# AVIATION MAINTENANCE TECHNOLOGY MILITARY MASTER CLASS PROGRAM FAQ'S



## 1. WHAT IS THE PROGRAM SCHEDULE?

The Aviation Maintenance Master Class program (an approved Navy SkillBridge Program) is offered each year during the Winter and Summer quarters for 8 weeks. The class runs Tuesdays - Saturdays.

- Tuesdays - Fridays: 0730 to 1530 at NAS Whidbey
- Saturdays: 0800 to 1400 at EvCC Aviation Facilities on Paine Field

## 2. HOW DO I GET STARTED?

Attend an information session at NAS Whidbey. Contact Fleet and Family Support Services on base for dates and times or call EvCC Aviation office. (see contact info below)

## 4. WHAT ARE THE PROGRAM ENTRY REQUIREMENTS?

FAA Form 8610-2 preferred and permission from commanding officer for temporary duty assignment.

## 5. HOW DO I GET MY FAA FORM 8610-2?

Fill out the form at this link:

Print two original copies.

## 6. WHAT IS MY NEXT STEP AFTER PRINTING MY FAA FORM 8610-2?

Contact the regional Flight Standards District Office (FSDO) for an appointment with an FAA inspector. (see contact information below)

## 7. WHAT SHOULD I TAKE WITH ME TO MY FAA APPOINTMENT?

- Photo ID
- Documented experience with NEC
- Certificate of Release or discharge listing total time in service and NEC Codes OR DD 214 Form
- Training Records
- Encouraged: Letter form XO, Maintenance Officer or Classification Officer

## 8. HOW DO I REGISTER FOR CLASS?

You will be contacted by the EvCC Aviation office providing you registration codes and instructions to register.

## 9. HOW MUCH IS THE CLASS?

For this 18 credit program the current cost is \$1,498.28 + fees

## 10. HOW DO I PAY FOR THE CLASS?

For funding information contact the EvCC Veterans Resource Center. (see contact info below)

## **11. WILL I HAVE MY A&P LICENSE WHEN I'VE COMPLETED THE PROGRAM?**

No. Completion prepares you to move forward with your FAA written and Oral & Practical (O&P) FAA testing. The cost of FAA testing is separate from the program. Contact the Veterans Resource Center for sources of funding.

## **12. I'D LIKE TO PURSUE MY AVIATION MAINTENANCE COLLEGE CERTIFICATE OR DEGREE IN ADDITION TO THE MILITARY MASTER CLASS. WHAT SHOULD I DO?**

Once you have received your FAA license you are eligible to receive 60 credits towards a college degree. Contact the EvCC Aviation office to set up an appointment with an Advisor.
